PARTICIPATION TERMS TO THE ACTIVITY
“SuperCopa”
(-2017/2018 sport season-)

CONDITION 1. SCOPE.

FUTBOL CLUB BARCELONA (hereinafter referred to as FC BARCELONA, FCB or the CLUB) shall organize an action called “SuperCopa” (hereinafter referred to as the “activity”) aimed solely and exclusively at those who hold and maintain the status of “Barça Fans”, participating under the terms and conditions contained herein

How to take part in the activity and how it works shall be communicated and promoted, among FC BARCELONA’s other means of communication, on its official website (www.fcbarcelona.com), social media of FC Barcelona and the mailings the CLUB sends its “Barça Fans” community. Among all the participants shall get one (1) winner. The prize, for him/her and one (1) accompanying person, will consist in:

- i. one (1) set of two invitations for the winner and a companion as voluntarily determined by the former, to attend the aforesaid match.
- ii. one (1) return boarding pass for the winner and another for the companion as voluntarily determined by the former from the origin of the winner to the city of Barcelona, for a maximum value of two thousand euros (€2,000). Should the value of the winner’s air fare and if applicable, that of the companion determined by the former sibe greater than two thousand euros (€2,000), the winner must assume at his/her own and exclusive cost the difference between the real value and the two thousand euros (€2,000) provided by FCB. In this regard, it is specified that (i) departure on 12/08/2017 shall always be from the nearest airport to the city where the winner resides and (ii) the return shall be to the same airport on 14/08/2017, it being at the cost of the winner and if applicable his/her companion for all due purposes, to pay for any travel to the airport in question.
- iii. Accommodation for two (2) nights at a hotel in Barcelona (nights 12 and 13 of august of 2017), for the winner and the companion as voluntarily determined by the former.
- iv. Expenses corresponding to travel between Barcelona airport and the hotel determined by FCB as an integral part of the prize and from the hotel to the airport, and from the hotel to the “Camp Nou” stadium in Barcelona and from the stadium to the hotel.
- v. Two (2) tickets to attend *Camp Nou Experience*.

Full details and conditions of use of the Prize are described in Condition 6 below.

CONDITION 2. PARTICIPATION PERIOD AND PUBLICATION OF TERMS.

The participation period for the activity shall begin on 13 July 2017 and end on 3 August 2017.

These terms and conditions shall be published on FC BARCELONA’s official website (www.fcbarcelona.com) to inform all the participants who want to take part in the process and course of the activity and the draw.

CONDITION 3. AUTHORISATION OF USE OF PERSONAL DATA.

In accordance with Organic Law 15/1999 of 13 December on Protection of Personal Data (LOPD) and Spanish Law 34/2002 of July 11 on Information Society Services and Electronic Commerce, FC BARCELONA hereby informs “Barça Fans” participating in the activity, that their data such as their email address provided voluntarily for the purposes of registering and identifying as a participant in order to take part in the activity:

- a) Shall be compared with the data already in FC BARCELONA’s databases (which consists of the authorized file, the CLUB being responsible therefor) to verify that it matches and for correction purposes.
- b) In the case that the data is not registered (for example, email), it shall be incorporated into the file and used to promote the “Barça Fans” community and/or group.
- c) Furthermore, the CLUB shall be granted authorization to make the communications it deems appropriate in relation to the activity and the draw subject of these conditions, and also those it considers necessary to inform them of sporting, social and/or any other events it may organize and develop, in compliance with the aims set out in its articles of association, and to send promotions and commercial offers related to the services and products of the CLUB or third parties sponsors pertaining to the industry or activity of consumer goods of leisure, air transport, sports textile, appliances, e-commerce among others; with FC BARCELONA, provided that the data for communications is processed directly by the CLUB or an authorized third party that provides services to FC BARCELONA.
- d) All the data included in the aforementioned file are confidential and can only be used under the terms and conditions set out herein.

e) The name and surname(s) of the winning participant will be published on FC BARCELONA's official website, along with the image(s) that they may send at the request of the CLUB.

f) However, participants who are of legal age, may at any time exercise their right to access, rectify and/or cancel by sending notification in writing, together with a photocopy of the person's in question ID to the party responsible for the file, FC BARCELONA, at its headquarters: Avinguda Aristides Maillol, s/n, 08028 Barcelona, or to the following email address: lop@fcbarcelona.cat, specifically stating the right exercised.

CONDITION 4. PARTICIPATION PROCESS.

All those interested in taking part in the participation process, regardless of their status as members of the CLUB, must fulfil the following conditions:

a) Should the winner be a minor (according to the applicable US Law), his/her companion must necessarily be one of his/her progenitors and/or an adult person who is entrusted with their legal representation and guardianship. If the companion is a minor, the winner must be an adult person who is entrusted with their legal representation and guardianship.

c) Fill in the form correctly (name, surname, date of birth, province and country of residence and email)

d) Have the status of "Barça Fan" and maintain it for at least until the date of the draw, scheduled for 4 August 2017.

e) Have an email address which is "registered" in FC BARCELONA's "Barça Fans" database.

f) When the above is done, the email of the "Barça Fans" will be registered and participation in the prize draw for the activity is automatic.

g) Each "Barça Fan" participant can take part once (1) and will therefore only register once (1). Any duplication will be monitored by a computer security system to ensure that only one (1) registration is admitted per participant, all additional registrations by the same person shall be terminated.

h) One (1) single file will be created from a correct "registration of participation" as has been stated in this condition.

CONDITION 5. DRAW PROCESS.

a) In the event that only one (1) participant takes part in the activity, the draw shall not be held as he/she shall automatically be the winner. Therefore, this person shall be awarded the prize directly, without the draw being necessary.

b) Otherwise, a draw shall be held, solely between participants who have correctly signed up for the activity subject to these conditions, resulting in one (1) winner. Therefore, participants who do not sign up correctly for the activity shall be excluded.

c) All participants shall be assigned a sequential number according to the chronological order of participation, in order to have a consecutive number range (for example from 1 to 50).

d) The draw, if held, shall be completed using a computer system, which according to a random combination chosen by computer, shall choose eleven (11) sequential numbers from those assigned to participants who have signed up correctly for the activity as indicated in foregoing paragraph c), which must correspond with emails in the participants database. The first (1) shall be the "winner", and the remaining ten (10) shall be "reserves".

e) In the event that it is not possible to confirm the trip with the winner four (4) weeks before the end of the period the prize will be deserted.

f) The draw shall take place before a Notary Public, on 4 August 2017.

g) The emails must correspond to registered "Barça Fans". Otherwise, the reserves shall be contacted. The following will be asked for checking purposes: (i) name, (ii) surname(s) and (iii) Barça Fans member status.

h) Once the draw has been held, the Notary Public shall terminate the proceedings, stating the identification of the winning participant (name and surname), as well as the reserves.

i) The result of the draw shall be notified to the winning participant via the email given for the purposes of taking part in the activity, along with the information relating to the logistics of delivery and collection of the prize and the trip.

j) By taking part in this activity, the "Barça Fans" participants, **EXPRESSLY AGREE** (i) to these conditions, and (ii), if they are the winners of the activity, to the FUTBOL CLUB BARCELONA sending them an email to the address provided for the purposes of taking part as a means of checking, for all purposes, communications by the CLUB indicating the aforementioned condition. This shall take place the week after the draw. If it is not possible to contact the winning "Barça Fan" within twenty-four hours (24 hours) starting from the moment the first notification, for any reason or circumstance beyond the FUTBOL CLUB BARCELONA, the winner shall lose his/her rights to the prize, it being awarded to the first reserve and so on successively.

In this regard, it is specified that (i) departure on 12/08/2017 shall always be from the nearest airport to the city where the winner resides and (ii) the return shall be to the same airport on 14/08/2017, it being at the cost of the winner and if applicable his/her companion for all due purposes, to pay for any travel to the airport in question.

If there are disagreements regarding the activity and/or the interpretation of these conditions, the Courts and Tribunals of the City of Barcelona are deemed competent to rule on any disputes that may arise, therefore participants in this activity expressly waive any other jurisdiction that may correspond to them.

CONDITION 11. WRONG DATA.

In the event that there is an error in the data provided by participants and, more specifically, the winning participant for any reason or circumstance, making it impossible to identify and/or contact him/her, the CLUB shall be released from all liabilities, the winner losing his/her right over the prize, which shall be awarded to the first reserve and so on successively.
